#### **SECTION I. INTRODUCTION**

This Annual Goals & Accomplishment Report outlines Ventura County Public Works Agency (VCPWA) Program and Policies that it implements and adheres to ensure compliance with Title VI of the Civil Rights Act of 1964 (Title VI). Part of those policies is to conduct program area reviews which includes data collection and analysis to identify and address discrimination, if found. The Federal Highway Administration (FHWA) requires recipients of Federal-aid funds to prepare this report identifying VCPWA's accomplishments, goals, roles, responsibilities, and procedures to ensure compliance with Title VI Civil Rights Act. VCPWA's Title VI reporting year runs from October 1 through September 30 annually which mirrors the federal fiscal year.

This report establishes goals derived by the data collected from each assessment conducted in the following areas: Title VI Training, Dissemination of Information, Title VI Complaints, Public Outreach, Environmental Justice, Right-of-Way, Construction, Subrecipient Compliance Monitoring, and Language Assistance. The following report focuses on goals and accomplishments for the 2023 to 2024 federal reporting year.

#### SECTION II. OVERVIEW

As a recipient of federal financial assistance, VCPWA, including its direct grant recipients and subrecipients, is obligated to adhere to, and is committed to achieving full compliance with Title VI and all related nondiscrimination laws. It incorporates the principles of Environmental Justice (EJ), Executive Order 12898 into its programs, policies, and activities to ensure there are no transportation related activities that disproportionately impacts low-income and minority populations. Executive Order 13166 on Limited English Proficiency (LEP) is also included to ensure meaningful access is provided to persons who are limited in the English language.

#### SECTON III. TITLE VI POLICY STATEMENT

VCPWA, under Title VI and related statutes, ensures that no person shall on the grounds of race, color, national origin, sex, disability, religion, sexual orientation, or age, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity it administers.

VCPWA further assures that every effort will be made to ensure nondiscrimination in all its programs and activities, whether those programs and activities are federally funded or not.

The Director of VCPWA and the Title VI Coordinator are authorized to ensure compliance with provisions of this policy and with the law, including the requirements of Title 23 Code of Federal Regulations (CFR) 200 and Title 49 CFR 21.

#### SECTION IV. ORGANIZATION, STAFFING AND STRUCTURE

The Administrative Division of Public Works includes the Director of VCPWA, Gregg Strakaluse, and Assistant Director, David Fleisch, and their immediate staff. VCPWA is comprised of five Departments consisting of 356 employees serving approximately 95,001 residents in unincorporated Ventura County during this reporting period.


**<u>Roads & Transportation</u>**: Responsible for the planning, designing, funding, operating, and maintaining 542 miles of County unincorporated road system and public transit needs for the County. Roads & Transportation is the only Department receiving federal funding through the Federal Highway Administration.

<u>Watershed Protection</u>: Provides for the control and conservation of flood and storm waters and the protection of watercourses, watersheds, public highways, life and property in the district from damage or destruction from these waters.

<u>Water & Sanitation:</u> Provides water and sanitation services to customers through two divisions. The Utility Services Division and the Integrated Waste Management Division (IWMD).

<u>Central Services</u>: Provides support services to all PWA Departments to include clerical, fiscal, real estate services, health & safety, technology and facilities, payroll, and personnel.

**Engineering Services:** Engineering services is responsible for a wide range of engineering services to clients within the County of Ventura organization and the public. Our services include: the capital program and project management, facilities contracting, land development, flood damage mitigation, land surveying and surveyor support.




The Department Directors are responsible for familiarizing themselves with the requirements of Title VI at the Department level. Each Department has designated a person to serve in the role of Title VI Administrator for the day-to-day administration of the Title VI Program under the direct supervision of the Title VI Coordinator. The Title VI Coordinator works together with all Department Directors and Administrators to ensure the successful implementation of VCPWA's Title VI Program.

To comply with Title VI, Departments are responsible for: Collecting and analyzing data regarding participants in and beneficiaries of a department's programs, activities, and services to determine benefits and burdens to persons protected by Title VI.

- Working proactively with Department staff to prevent disparities and take corrective action when necessary.
- If complaints arise, work to resolve complaints and track complaint activity.
- Ensuring Environmental Justice by considering any potential disproportionate adverse human health, environmental, social, and/or economic effects of Department activities on communities of color and low-income populations.
- Ensuring programs, services, and benefits of the Department are accessible to people with limited English proficiency.
- Providing convenient access to information and meaningful public participation opportunities for all Department services, programs benefits and projects.
- Ensuring dissemination of Title VI information and notices to the public to provide meaningful access to departmental programs and activities. Title VI non-discrimination notices should be included in all applicable Department or project documents and public meeting materials.
- Providing the Title VI Coordinator with an annual report of Title VI accomplishments from each department for the previous year and goals for next year.

Pursuant to 23 CFR 200, VCPWA has established an organizational structure Title VI Unit as shown on the diagram below which reflects the current reporting structure and staffing for this reporting period. The Title VI Coordinator is appointed by and reports to the Director of Public Works Agency.



#### Title VI Coordinator Responsibilities

VCPWA's Title VI Coordinator is responsible for developing, maintaining, updating and ensuring compliance in accordance with VCPWA's Title VI Plan.

#### Title VI Administrator Responsibilities

Title VI Administrators work with the coordinator to ensure their respective Departments comply with Title VI regulations and meet the objective of the Title VI Plan, meet Federal & State requirements and provide training opportunities for staff. Each of the Administrators will maintain data related to Department.

#### SECTION V. COMPLAINTS

VCPWA received neither formal nor informal complaints that were directly or indirectly related to Title VI during the reporting period. Complaint procedures are incorporated into the Title VI Plan and will be followed if any formal Title VI complaint is filed per the procedures. A Title VI Notice to the Public is also included in the Plan informing the public of their Title VI rights and how to file a Title VI complaint. #### **Advanced Planning Studies**

#### Active Transportation Plan

In February 2024, Roads & Transportation completed its very first Active Transportation Plan (ATP) designed to improve our transportation system that supports and encourages different modes of travel such as walking and biking. The ATP includes recommendations for prioritizing infrastructure improvements in the unincorporated County based on public and stakeholder input.

<u>Feasibility Study - Camarillo to California State University Channel Islands (CSUCI) Shared</u> Roads & Transportation was awarded a Transportation Development Act (TDA) Article 3 grant in the amount of \$132,795 for the development of a Shared-Use Path from Camarillo CSUCI Feasibility Study. The feasibility study will determine potential alignments of a Class I shareduse path along Calleguas Creek between the City of Camarillo to CSUCI and will include rightof-way needs, discussion of ownership and maintenance, utility conflicts, potential environmental constraints and lighting needs along the path. The feasibility study is expected to be completed in April 2025.



The primary function of the PS is to issue encroachment permits for permanent construction or temporary activities in the county-maintained road right of way. In addition, the Permits Section enforces and regulates local laws as it relates to unpermitted activities or construction and unauthorized encroachments. The PS answers inquiries and investigates concern/complaints from the public. This Section meets the public most frequently at the front counter. The PS collaborates with other RT staff persons, other county agencies, and local cities, applicants/permittees, contractors/utilities, residents and property owners., The PS collects permit fees, special fees, and traffic impact mitigation fees (TIMFs)

The Permit Counter provides support to the County as a "one stop shop" for the public, the building industry, and the development community. The counter staff assists our customers in determining the type of permit needed and aids throughout the process. VCPWA supplies staff at its public counters with "I Speak" cards to help LEP individuals identify the language they speak. All Interpretation services that are provided at the front counter and over the phone is in Spanish. The Permit's Section maintains a tracking system that records all language assistance that is provided throughout the year.



#### SECTION IX. ENVIRONMENTAL JUSTICE

Environmental justice (EJ) and Title VI apply to every stage of the Transportation decision-making process. As recipients of federal funding, PWA-RT is responsible for implementing EJ requirements and non-discrimination principles into transportation planning, project development and environmental scoping and NEPA/CEQA documentation.

It is PWA-RT's responsibility for assuring that the determination of environmental effects and any resulting impacts and mitigated measures are executed in accordance with Title VI. This process requires consideration of all social, economic, and environmental effects of a proposed project on minority and low-income populations impacted by our transportation programs and activities.

Many projects designed in PWA-RT are classified as Categorical Exemptions from CEQA/NEPA because they typically do not have substantial impacts on the environment. Projects that identify potential impacts and identify any specific environmental justice issues will undergo a more formalized evaluation as part of the NEPA/CEQA process. The table below lists the number of transportation projects during the reporting period and indicates the level of evaluation during the environmental process. None of the projects disproportionately impact any minority and disadvantaged communities. This ensures that everyone has equal access to a healthy environment.

#### **Environmental Justice - Summary**

- There were five (5) pavement resurfacing projects that were exempt for the following criteria: CEQA Guidelines section 15301 (c) because it consists of minor alterations of existing structures and facilities, with no possibility of significant effects on the environment either individually or cumulatively.
- There were two bike lane projects on Rose Avenue that were combined into one environmental document. A mitigated Negative Declaration was prepared pursuant to the provisions of CEQA.
- There was one (1) Slope Repair project that was exempt for the following criteria: CEQA Guidelines section 15301 (c) and (f) because of minor alterations on existing highways and streets and similar facilities
- There were (4) Emergency projects that were statutorily exempt under CEQA pursuant to Section 15269 (b) which exempts emergency repairs to publicly or privately owned service facilities necessary to maintain service essential to the public health, safety, or welfare". These included one (1) Culvert repair to restore road to essential traffic, one (1) bridge repair, one (1) roadway washout, and one (1) slope repair.
- There was one (1) road widening project that is currently in the Environmental stage that requires NEPA (Environmental Assessment) and CEQA (Environmental Impact Report) pending clearance which in anticipated in the Fall of 2025.
- There was one (1) bridge rehabilitation project that was exempt for the following criteria: CEQA Guidelines section 15301 (c) because it consists of minor alterations of existing structures and facilities.

#### SECTION X. RIGHT OF WAY

VCPWA's Real Estate Services manages and coordinates the appraisal of real property for all Public Works Projects. The right of way acquisition process entails appraisals of property, negotiations of terms and condition for all acquisitions, assistance in the relocation of displaced individuals if any, property management and utility relocation & coordination. It is the responsibility of the Right of Manager to ensure that all right of way appraisal and negotiations functions are executed in accordance with Title VI. All real property acquisitions performed by VCPWA fully comply with the Federal Uniform Relocation and Assistance Act of 1971.

#### **Right of Way Qualification Certification**

Local Agencies must meet certain qualifications and certifications to work on right-of-way projects. Caltrans qualifies local agencies to perform their own R/W functions based on the local agency's qualifications, the size of their staff and their ability to perform the technical work and subsequent reviews. On December 21, 2023, Real Estate Services' Level Two Qualification Certification was renewed by Caltrans effective January 1, 2024, and expiring on January 1, 2027 (Refer to Exhibit 5)

Real Estate Services consists of skilled professional staff of R/W Agents who play a vital role in contribution to VCPWA by delivering right of way services for transportation projects. The following R/W staff have been certified and have the required expertise to perform right of way work:

Some of our projects take place in disadvantaged communities where community engagement is crucial when minimizing unintended project impacts. The Roads & Transportation's Title VI Administrator provides support to D & C ensuring Title VI procedures are in place and regularly assesses D & C's performance under Title VI.

#### Consultant Work Orders & Stand-Alone Contracts (Design Phase)

Consultants are selected according to the procedures outlines in VCPWA's Processing Procedures Manual (PPPM) and procurement policy, Local Assistance Procedures Manual for federally funded projects and in accordance with Federal/State Regulations.

Consultant solicitations detail how qualifications are evaluated and the required technical requirements. For federally funded contracts, additional provisions for the compliance with the Disadvantaged Business Enterprise (DBE) program, are added to the solicitation and contracts. Consultants are selected based on the qualifications submitted and/or interviews. For smaller contracts (<\$500,000, a minimum of three consultants if possible are selected and their Statement of Qualifications are reviewed and scored based on the criteria included in the solicitations. For larger contracts >\$500,000, a minimum, of three consultants are interviewed if possible. Upon selecting the most qualified consultant, the independent cost estimate is compared to the consultant's proposal and an agreement is negotiated.

There was a total of **10** Consultant Work Orders and **10** Stand Alone Consultant Contracts that were executed in the design phase during the reporting period. The value of these contracts totals \$1,479,975. The scope, size and duration of these contracts vary in size. The table below includes the list of consultant contracts executed from October 1, 2023, through September 30, 2024.

#### **Summary for A&E Contracts**

In the reporting period, only one consultant contract involved federal funds:

Rumble strip and Curve Warning Signs Project – HSIPL-5952(219). The solicitation for traffic design services included notifications to proposers that VCPWA affirmatively ensures that any contract entered following the solicitation would provide Disadvantaged Business Enterprises (DBE) full and fair opportunity to submit bids in response to the solicitation and would not be discriminated against on grounds of race, color, or national origin in consideration for an award.

Included in the solicitation and contract were Appendix A and E assurance clauses. The Solicitation was advertised on the County website and emailed to several consultant firms. Although the contract had a zero percent goal due the lack of opportunity for subconsultants on this contract, the solicitation was sent to several DBE's firms providing them the opportunity to submit Statement of Qualifications as a prime consultant. Two Statement of Qualifications were received. After evaluations were completed, a contract was executed with Kimley Horn in the amount of \$331,000.

 Requests for Qualifications for environmental services were issued during the reporting period as a response to the 2023/2024 storm events. Statement of Qualifications were received and were evaluated and scored according to the criteria listed in the Request for Qualifications. From that Solicitation, three consultant contracts were executed with the following firms:

To ensure equal opportunity, projects are advertised in the local newspaper, twice, 30 calendar days for federally funded contract and 13 days for non-federally funded contracts, prior to the bid due date. Roads & Transportation uses an electronic bidding system "Bonfire" that allows for the digital submission and evaluation of bids. All construction notices to bid include Title VI Non-Discrimination statements. All bids are reviewed for accuracy, proper submittals and execution. After bids have been tabulated and analyzed, the contract is awarded to the lowest responsible bidder.

For federally funded construction projects contracts, Tittle VI compliance is included on the agenda for the preconstruction meetings to ensure compliance requirements are understood. Title VI is monitored and reviewed in the field as a part of the on-site reviews and interviews.

There were no federally funded projects constructed in this reporting period. A total of two Active Transportation Program (ATP) Cycle 5 projects (State Funded) were in construction during this period:

- El Rio Pedestrian Improvements Project (located in a Disadvantaged Community)
- Santa Rosa Bike Lane & Pedestrian Improvements Project.

ATP ensures that disadvantaged communities fully share in the benefits of the program. These projects include dozens of new crosswalks, pedestrian beacons, construction of new sidewalk, bike lanes, bulbouts, and other related work to ensure that streets are safer for people walking, bicycling and traveling in the community.

#### Annual Work Orders & Stand-Alone Contracts (Construction Phase)

During construction, there was a total of **2** Stand-Alone Consultant Contracts and a total of **5** Consultant Work Orders that were executed during the construction phase. The value of these contracts totaled \$1,318,718. The scope, size, and duration of these contracts vary in size. All the consultant contracts that were procured were for construction support services and material testing and inspection services. There was a total of **5** Construction Contracts awarded during this reporting period totaling \$12,282,017. PWA-RT advertises construction contracts opportunities in the local paper and through the County's electronic bidding system "Bonfire". For all federal projects, all projects out to bid include DBE & Title VI Provisions, FHWA Form 1273 and Exhibit 12-G Federal - aid Contract Language. Although none of the projects this reporting period were federally funded, all bid documents and construction contracts that are funded with Local Roads Funds include standard provisions regarding non-discrimination in hiring and in subcontracting.

#### **PLANNED ACHIEVEMENTS & GOALS**

- Continue to focus on compliance with the framework of our federally funded transportation projects planned for 2024/2025. Continue to conduct reviews of pre-award and post-awards of construction audits to ensure DBE and Title VI Assurance Language is included. Staff will continue to work on projects during the next reporting year and will be addressed in the upcoming 2024-2025 Title VI Accomplishment Report.
- Data Collection: Title VI Administrator shall assist Project Manager with research concerning demographic and accessibility in neighborhoods where projects will be constructed
- Create better content for social media and improve our outreach efforts.

One of our key goals is to provide motorists with a good driving experience on County roads. One way of accomplishing this is through customer surveys. These surveys are conducted upon completion of road resurfacing projects and are used to help the Design & Construction Section by adjusting construction and traffic management strategies and improve overall success on future resurfacing projects.

VCPWA strives to involve our community as much as possible. To keep the public informed and engaged VCPWA maintains a website that is updated regularly to keep the public informed about all active and upcoming construction projects, contact information, and timeline/milestone dates. This also provides the opportunity for feedback from the public regarding projects.

#### **PLANNED ACHIEVEMENTS & GOALS**

Explore conducting customer surveys prior to construction to help Roads & Transportation plan projects, adjust construction, look at different traffic management strategies and improve the success on future projects.

#### **Public Outreach Log – Construction Phase**

#### 50616 – El Rio Pedestrian Improvements

- In January of 2024, the El Rio community residents received a letter addressing the construction of the sidewalks and driveways that were affected on each property.
- A public community meeting was held at the Rio Del Valle Gymnasium in Oxnard on January 29, 2024.
- A Right of Entry Cover Letter and Permit, Unauthorized Encroachment Cover Letter, and J3 Permit were translated into Spanish and provided to both residents and surrounding businesses.
- A week-by-week projection was provided to residents. See figure 1.



#### 50622 - Santa Rosa Bike Lane & Pedestrian Improvements

- In July 2024 flyers were mailed to residents with a project description, construction timeline, road closures, parking restrictions and other common FAQ's.
- A Facebook post and additional notices were sent out to residents and businesses with upcoming construction work and what to expect.
- On January 6, 2025, VCPW-RT held a ribbon cutting ceremony for the Project and the community was invited to attend.

#### 50632 – Pavement Resurfacing – Ojai Area

- Public outreach Notice of Road Closure and Notice to Residents were distributed via mailers, postings, and social media.
- Roads & Transportation engaged the community early in the process by distributing notices and online map postings providing information about the project and the upcoming road closures.
- At the end of the project, a Customer Satisfaction Survey was sent to the 453 residents within the project limits. A total of 9% of the residents responded to our survey. The general sentiment in the responses received were positive achieving an overall Project score of 3.2/5.

#### Labor Compliance

The Administrative staff is responsible for the following when administering construction contracts:

- Attending preconstruction meeting. Discuss Labor Compliance, DBE Requirements, and subcontracting provisions in the contract.
- Review and confirm all Certified Payroll Records (CPR).
- Go over requirements for Owner/Operators and 2<sup>nd</sup> and 3<sup>rd</sup> Tier Subcontractors.
- Review employee interviews and cross-check wage rates and classifications against certified payrolls.
- Ensure Compliance with Title VI requirements.
- Provide technical guidance to Contractors & Subcontractors.
- When necessary, recommend funds to be withheld from progress payments made to the contractor for inadequate CPR and missing documents.
- Ensure subcontractors are paid promptly. VCPWA will take the necessary steps to ensure prompt payment to all subcontractors. Failure by the contractor to comply with 49 CFR §26.13 will be subject to the penalties, sanctions, and other remedies.

#### **SECTION XIII. TRAFFIC**

The Traffic Section is a small team of five (5) consisting of one Traffic Engineering Manager, one Engineer, two Engineering Technicians and one part-time Student Worker. Its primary functions include, but are not limited to, investigating citizen requests/complaints, preparing engineering reports and surveys, providing traffic support services, traffic signal & communication network systems, preparing work orders, legal reviews, and much more. Below are some examples of completed projects and tasks accomplished by the Traffic team in Fiscal Year 2023/24.

#### **Citizen Requests/Complaints**

Through VCPWA Connect (citizen concern portal) around 72 citizen requests/complaints were addressed by the Traffic Section. Some of the entries in the database involved high vehicle speeding, missing roadside signs, sight distance evaluations, speed hump requests, etc. To adequately respond to the request/complaint submitted, the Traffic team performed field investigations, conducted traffic counts, reviewed collision history, created exhibits, and summarized findings/actions for the citizen via the online portal. In special cases speed humps are installed if the citizen complies with the County speed hump policy and meet all warrants.



#### **Traffic Support Services**

The Traffic Section plays a vital role when it comes to reviewing utility work/road closures for the Permits team. In FY 23/24, the Traffic team reviewed and approved approx. 75 traffic control plans submitted by utility companies (i.e. Edison, Gas Company, etc.) for routine maintenance work on County roadways. These traffic control plans range in complexity from easy road closures with detours to complicated one-lane, two-way traffic operation with flaggers. Additionally, the Traffic team reviewed Special Event permits which traffic control plans varied in size and crossed County limits. Such traffic control plans included the Mountains to Beach Marathon, Ojai Valley Marathon, Wings Over Camarillo Air Festival, NBVC Point Mugu Air Show, etc.

#### **Engineering Reports and Surveys**

PWA-RT has roughly 80 County roadways which are not prima facie speed limits (i.e. 25 MPH for residential or 55 MPH for two lane undivided highways), therefore, require an Engineering & Traffic Survey (E&TS) to establish a safe and reasonable speed limit. In accordance with State principles and guidelines, an E&TS involves a radar survey of 100 free-flowing vehicles (50 per direction), traffic volumes, collision history, adjacent road characteristics and to determine the 85th percentile of driving speeds which is how speed limits are set. In FY 23/24, the Traffic team performed several E&TS due to citizen concerns regarding perceived speeding. Each study found that the posted speed limit was appropriate for the roadway and no alterations were justified.


#### Work Orders

In FY 23/24, the Traffic Section completed over 40 work orders with the assistance of the Operations and Maintenance team. Work orders involved minor work like to remove/install roadside signs to major improvements like school traffic safety enhancements. These work orders involved field investigations, traffic counts, collision reports, sight distance checks, and public outreach/engagement. Through Mustang Media, the Traffic team can notify constituents in advance (or at completion) on a work order process via various social media platforms.



#### Legal Review

The Traffic team completed about 50 tort claims in FY23/24. Tort claims are routed by Risk Management and/or County Counsel involving a Claim for Damage or Injury case. Sometime these cases occur outside the County Road right-of-way and in private property (i.e. shopping center parking lot, school grounds, etc.). These reviews require a thorough assessment of the claim, reviewing the County Road index, coordinating with interdepartmental staff, and providing a response to the requesting party. Common responses include a Declaration statement signed by the Traffic Engineering Manager indicating which after extensive review of County records, the alleged incident did not occur on a county road right-of-way. For incident which occurred on County Road right-of-way, a separate process is followed. Image below shows the incident which happened within the City of Oxnard and not on a County owned and maintained roadway.



#### Traffic Signal & Communication Network Systems

In FY 23/24, the Traffic team assisted the Design & Construction team in working to prepare plans and specifications for a Countywide Systemic Signal Improvement Project. This project will upgrade all the 44 traffic signal controllers and software, integrate wireless communication at each signal, create a traffic management center at the County Office for instant monitoring, enhance the signals with retroreflective bands around each signal head, upgrade the pedestrian push buttons, and install a high-friction surface treatment at nearly half of our 44 signals.



#### **SECTION XIV. OPERATIONS & MAINTENANCE**

The Roads and Transportation Operations & Maintenance (O&M) Division preserves and provides routine maintenance of **542** miles of road and **158** bridges within the County of Ventura. Routine road maintenance may include but is not limited to:

- Road striping, symbolling, and signing
- Rural tree trimming
- Maintenance and installation of culverts and storm drains
- Shoulder repairs and grading
- Repairing and filling potholes
- Crack sealing
- Storm debris removal
- Culvert and catch basin cleaning
- Roadside ditch maintenance
- Guardrail maintenance





#### **Citizen Requests/Complaints**

The O&M Division also receives public concerns or comments via phone, email or through the Citizen Request Management (CRM) portal to investigate public roadway concerns. All requests are promptly investigated, and in most cases, maintenance crews can repair or address most concerns. During the reporting period, O&M addressed 774 citizen requests received through CRM.



#### **Completed Activities & Achievements**

As a result of the 2024 storm events, the O&M Division removed approximately **16,025** cubic yards of storm debris and **60** fallen trees to ensure the roads were free and clear of obstructions to ensure public safety

#### SECTION XV. LANGUAGE ASSISTANCE

Language assistance is one component of VCPWA's efforts to provide an appropriate mix of language assistance measures to meet the needs of individuals within the County of Ventura who are "limited English proficient". Limited English proficient (LEP) individuals are those who have limited ability to read, write, speak, or understand English. VCPWA maintains an up-to-date list of employees who can provide interpretation and translation services in Spanish upon request.

It is VCPWA's policy to provide timely and meaningful access to our LEP residents, visitors, and customers by providing language assistance whether over the phone, in writing or through social media.



VCPWA can provide interpretation and translation services in Spanish in-house upon request. We have also contracted with a translation service "Language Line Solutions". This allows staff and customers to speak with a live translator over the phone in languages other than Spanish. "I Speak" cards are available at front desks throughout all department offices and divisions. VCPWA's will continue to provide on its website and in its outreach materials that language assistance is available upon request and free of charge. Our website is an Important method when communicating with the public including LEP individuals. Our website provides content in Spanish along with Google Translate as well as dedicated Spanish language for certain projects.



#### Written Translation

Written translation requests for document translations are received through VCPWA's SharePoint site from various departments in Public Works. Documents are uploaded in the system with specific instructions and timeframes when the documents are to be completed. The primary language in Ventura County and requested for document translation is Spanish. All requests for Spanish translations are provided by in-house interpreters. Currently VCPWA has two staff members who are qualified and certified for document translation.

Roads & Transportation continues to maintain a translation and interpretation tracking system (see table below):



# What does this mean?

The Ventura County Public Works Agency (VCPWA) strives to ensure that access to and use of all programs and all benefits derived from any activity it is responsible for will be administered without regard to race, color, national origin, sex, age, disability or socioeconomic status. The VCPWA will not tolerate discrimination by a County employee or any recipient of federal funds through VCPWA such as other agencies, contractors, consultants, suppliers, vendors, planning agencies.

An investigation will begin within 15 working days of receipt of the complaint. The complainant will be contacted in writing within 30 working days. The complainant may be interviewed as part of the investigation procedures. The VCPWA will complete the investigation within 90 days of receipt of the complaint.

# How does VCPWA enforce Title VI?

To ensure compliance with Title VI, related statutes, and the Presidential Executive Order on Environmental Justice, for programs and projects it is responsible for, VCPWA to:

- Avoid or reduce harmful human health and environmental effects on minority and low-income populations.
- Ensure the full and fair participation by all communities including lowincome and minority populations in the transportation decision-making process on federally funded projects.
- Prevent the denial of, reduction in, or significant delay in the receipt of benefits by minority and low-income populations on federally funded projects.

In addition, any recipient who receives federal financial aid is responsible to administer its programs and activities without regard to race, color, national origin, sex, age, disability or socioeconomic status.

# WHO IS RESPONSIBLE FOR TITLE VI?

### APPENDIX A

During the performance of this contract, the contractor, for itself, its assignees, and successors in interest (hereinafter referred to as the "contractor") agrees as follows:

- Compliance with Regulations: The contractor (hereinafter includes consultants) will comply with the Acts and the Regulations relative to Non-discrimination in Federally-assisted programs of the U.S. Department of Transportation, Federal Highway Administration, as they may be amended from time to time, which are herein incorporated by reference and made a part of this contract.
- 2. **Non-discrimination**: The contractor, with regard to the work performed by it during the contract, will not discriminate on the grounds of race, color, national origin, age, sex, or disability in the selection and retention of subcontractors, including procurements of materials and leases of equipment. The contractor will not participate directly or indirectly in the discrimination prohibited by the Acts and the Regulations, including employment practices when the contract covers any activity, project, or program set forth in Appendix B of 49 CFR Part 21.
- 3. Solicitation for Subcontracts, Including Procurements of Materials and Equipment: In all solicitations, either by competitive bidding, or negotiation made by the contractor for work to be performed under a subcontract, including procurements of materials, or leases of equipment, each potential subcontractor or supplier will be notified by the contractor of the contractor's obligations under this contract and the Acts and the Regulations relative to Non-discrimination on the grounds of race, color, national origin, age, sex, or disability.
- 4. **Information and Reports**: The contractor will provide all information and reports required by the Acts, the Regulations, and directives issued pursuant thereto and will permit access to its books, records, accounts, other sources of information, and its facilities as may be determined by the Recipient or the FHWA to be pertinent to ascertain compliance with such Acts, Regulations, and instructions. Where any information required of a contractor is in the exclusive possession of another who fails or refuses to furnish the information, the contractor will so certify to the Recipient or the FHWA, as appropriate, and will set forth what efforts it has made to obtain the information.

- 5. **Sanctions for Noncompliance**: In the event of a contractor's noncompliance with the Non-discrimination provisions of this contract, the Recipient will impose such contract sanctions as it or the FHWA may determine to be appropriate, including, but not limited to:
  - 1. Withholding payments to the contractor under the contract until the contractor complies; and/or
  - 2. Cancelling, terminating, or suspending a contract, in whole or in part.
- 6. **Incorporation of Provisions**: The contractor will include the provisions of paragraphs one through six in every subcontract, including procurements of materials and leases of equipment, unless exempt by the Acts, the Regulations and directives issued pursuant thereto. The contractor will take action with respect to any subcontract or procurement as the Recipient or the FHWA may direct as a means of enforcing such provisions including sanctions for noncompliance. Provided, that if the contractor becomes involved in, or threatened with litigation by a subcontractor, or supplier because of such direction, the contractor may request the Recipient to enter into any litigation to protect the interests of the Recipient. In addition, the contractor may request the United States to enter into the litigation to protect the interests of the Recipient.

#### APPENDIX B

#### CLAUSES FOR DEEDS TRANSFERRING UNITED STATES PROPERTY

The following clauses will be included in deeds effecting or recording the transfer of real property, structures, or improvements thereon, or granting interest therein from the United States pursuant to the provisions of Assurance 4:

NOW THEREFORE, the U.S. Department of Transportation as authorized by law and upon the condition that the Ventura County Public Works Agency (VCPWA) will accept title to the lands and maintain the project constructed thereon in accordance with Title 23 U.S.C., the regulations for the administration of the preceding statute, and the policies and procedures prescribed by the FHWA of the U.S. Department of Transportation in accordance and in compliance with all requirements imposed by Title 49, Code of Federal Regulations, U.S. Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Non-discrimination in Federally-assisted programs of the U.S. Department of Transportation pertaining to and effectuating the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252; 42 U.S.C. § 2000d to 2000d-4), does hereby remise, release, quitclaim and convey unto the California Department of Transportation all the right, title and interest of the U.S. Department of Transportation in and to said lands described in Exhibit A attached hereto and made a part hereof.

#### (HABENDUM CLAUSE)

TO HAVE AND TO HOLD said lands and interests therein unto VCPWA and its successors forever, subject, however, to the covenants, conditions, restrictions and reservations herein contained as follows, which will remain in effect for the period during which the real property or structures are used for a purpose for which Federal financial assistance is extended or for another purpose involving the provision of similar services or benefits and will be binding on VCPWA, its successors and assigns.

VCPWA, in consideration of the conveyance of said lands and interest in lands, does hereby covenant and agree as a covenant running with the land for itself, its successors and assigns, that (1) no person will on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination with regard to any facility located wholly or in part on, over, or under such lands hereby conveyed [,] [and]\* (2) that VCPWA will use the lands and interests in lands and interest in lands so conveyed, in compliance with all requirements imposed by or pursuant to Title 49, Code of Federal Regulations, U.S. Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Non-discrimination in Federally-assisted programs of the U.S. Department of Transportation, Effectuation of Title VI of the Civil Rights Act of 1964, and as said Regulations and Acts may be amended[, and (3) that in the event of breach of any of the above-mentioned non-discrimination conditions, the Department will have a right to enter or re-enter said lands and facilities on said lands, and that above described land and facilities will thereon revert to and vest in and become the absolute property of the U.S. Department of Transportation and its assigns as such interest existed prior to this instruction].\*

\*Reverter clause and related language to be used only when it is determined that such a clause is necessary in order to make clear the purpose of Title VI.)

### APPENDIX C

### CLAUSES FOR TRANSFER OF REAL PROPERTY ACQUIRED OR IMPROVED UNDER THE ACTIVITY, FACILITY, OR PROGRAM

The following clauses will be included in deeds, licenses, leases, permits, or similar instruments entered into by Ventura County Public Works Agency (VCPWA) pursuant to the provisions of Assurance 7(a):

- A. The (grantee, lessee, permittee, etc. as appropriate) for himself/herself, his/her heirs, personal representatives, successors in interest, and assigns, as a part of the consideration hereof, does hereby covenant and agree [in the case of deeds and leases add "as a covenant running with the land"] that:
  - 1. In the event facilities are constructed, maintained, or otherwise operated on the property described in this (deed, license, lease, permit, etc.) for a purpose for which a U.S. Department of Transportation activity, facility, or program is extended or for another purpose involving the provision of similar services or benefits, the (grantee, licensee, lessee, permittee, etc.) will maintain and operate such facilities and services in compliance with all requirements imposed by the Acts and Regulations (as may be amended) such that no person on the grounds of race, color, or national origin, will be excluded from participation in, denied the benefits of, or be otherwise subjected to discrimination in the use of said facilities.
- B. With respect to licenses, leases, permits, etc., in the event of breach of any of the above Non-discrimination covenants, VCPWA will have the right to terminate the (lease, license, permit, etc.) and to enter, re-enter, and repossess said lands and facilities thereon, and hold the same as if the (lease, license, permit, etc.) had never been made or issued.\*
- C. With respect to a deed, in the event of breach of any of the above Non-discrimination covenants, VCPWA will have the right to enter or re-enter the lands and facilities thereon, and the above described lands and facilities will there upon evert to and vest in and become the absolute property of VCPWA and its assigns.\*

(\*Reverter clause and related language to be used only when it is determined that such a clause is necessary to make clear the purpose of Title VI.)

#### APPENDIX D

### CLAUSES FOR CONSTRUCTION/USE.ACCESS TO REAL PROPERTY ACQUIRED UNDER THE ACTIVITY, FACILITY OR PROGRAM

The following clauses will be included in deeds, licenses, permits, or similar instruments/agreements entered into by Ventura County Public Works Agency (VCPWA) pursuant to the provisions of Assurance 7(b):

- A. The (grantee, licensee, permittee, etc., as appropriate) for himself/herself, his/her heirs, personal representatives, successors in interest ,and assigns, as a part of the consideration hereof, does hereby covenant and agree (in the case of deeds and leases add, "as a covenant running with the land") that (1) no person on the ground of race, color, or national origin, will be excluded from participation in, denied the benefits of, or be otherwise subjected to discrimination in the use of said facilities, (2) that in the construction of any improvements on, over, or under such land, and the furnishings of services thereon, no person on the ground of race, color, or national origin, will be excluded from participation in, denied the benefits or, or otherwise be subjected to discrimination, (3) that the grantee, licensee, lessee, permittee, etc.) will use the premises in compliance with all other requirements imposed by or pursuant to the Acts and Regulations, as amended, set forth in this Assurance.
- B. With respect to (licenses, leases, permits, etc.) in the event of breach of any of the above of the above Non-discrimination covenants, VCPWA will have the right to terminate the (license, permits, etc., as appropriate) and to enter or re-enter and repossess said land and the facilities thereon, and hold the same as if said (license, permit, etc., as appropriate) had never been made or issued.\*
- C. With respect to deeds, in the event of breach of any of the above Non-discrimination covenants, VCPWA will there upon revert to and vest in and become the absolute property of VCPWA and its assigns.

This letter serves as a confirmation that the **County of Ventura** has retained the Right of Way **Qualification Level 2** status. The **County of Ventura** continues to be adequate to meet State and Federal requirements to perform right of way technical work in **Appraisals**, **Appraisal Review**, **Acquisitions**, **Utility Relocation** and **Railroad Coordination** as well as having the sufficient staff to perform these functions on more than one project at a time. The Local Public Agency is also allowed to partner with a prequalified Local Agency or the contracting with a private consultant(s) to perform one or more R/W specialties.

Additionally, the State acknowledges that the Local Agency has **George Andrade** as Contract Administrator to act as the official representative of the Local Agency with full authority and responsibility to manage right of way contracts.

This authorization is subject to the following conditions:

- 1. This authorization is effective as of **January 1**, **2024** and, absent earlier cancellation or modification, will expire on **January 1**, **2027**. Please apply at least ninety days in advance of this date if you wish to re-establish your qualified status.
- 2. This authorization is limited to Federal-aid local assistance projects that are not on the State Highway System (SHS). All other work, including all work on the State Highway System, requires prior written authorization on a project-by-project basis. The request for authorization must include a detailed plan that identifies all the right of way work required for the project, a detailed parcel specific list and cost estimate, a detailed scheduled time line with milestones, detailed work plans, and a list of the individuals who will perform right of way activities, broken down by functional area.

- 3. All right of way activities performed by the Local Agency on projects funded with Federal and/or State funds requiring monitoring or oversight will conform to the Department's policies and procedures which include compliance with the Department's utility policy on high and low risk underground facilities.
- 4. The Local Agency's work will be reviewed by Department staff for compliance. Department staff may perform spot checks of project files during the course of, or subsequent to the expiration of this authorization.
- 5. The Local Agency will inform the Department by letter of any organizational or policy changes affecting its nonqualified Local Agency right of way qualification status. Whenever possible, please provide this notification at least thirty days prior to the effective date of the change.
- 6. The Department may withdraw this **Level 2 Qualification** certification if deficiencies are found and not corrected within a reasonable period.
- 7. In accordance with the Right of Way Manual, Chapter 17, in sections 17.06.01.01 and 17.06.02.01, the Local Agency must advertise and seek competitive bids from consultants who meet the selection criteria for the right of way function needed on a project-by-project or time base method when there is State or Federal funding in the project.
- 8. The Local Agency has in their possession and use the most recent version of the Caltrans Right of Way Manual, Local Assistance Procedures Manual and Title 23 and 49 of the Code of Federal Regulations (CFR).



# VENTURA COUNTYWIDE STORMWATER POLLUTION PREVENTION PUBLIC OUTREACH

**Team:** Watershed Protection - Ventura Countywide Stormwater Quality Management Program (VCSQMP) – The VCSQMP includes the Cities of Camarillo, Fillmore, Moorpark, Ojai, Oxnard, Port Hueneme, Simi Valley, Santa Paula, Thousand Oaks, Ventura, the County of Ventura, and the Ventura County Watershed Protection District. These partners work together under the Ventura Countywide National Pollutant Discharge Elimination System (NPDES) Municipal Separate Storm Sewer System (MS4) permit, issued by the Los Angeles Regional Water Quality Control Board, and adopted by the State Water Resources Control Board under the Clean Water Act.

#### Goals

Public outreach, including education and building awareness, are critical components of the Program plan to support water quality pollution concerns and encourage people to act.

The goals of the outreach program are to:

- Raise awareness about stormwater pollution's impact on water bodies and promote mitigation solutions.
- Encourage behavior changes in waste disposal and stormwater pollution generation.
- Engage Ventura County communities, including youth, in mitigating stormwater pollution.

The Permittees identified elements crucial to establishing a successful outreach campaign, which include:

- Watershed Awareness.
- Identification of general and specific goals of the program.
- Identification of target audiences and key messages for those audiences.
- Consistent messaging using a unified brand name.
- Development of a watershed-based outreach program.
- Development of a model public education/public participation strategy for localization at the Permittee level.
- Development and implementation of a school-aged children education outreach program.
- Public Awareness Surveys to measure success and determine needs.

#### Accomplishments

The Permit requires the Principal Permittee to develop and implement a strategy to educate ethnic communities through culturally effective methods. According to the 2022 U.S. Census Quick Facts, persons of Hispanic of Latino origin were estimated to make up 43.6% of the Ventura County population. An estimated 38.6% of residents speak a language other than English at home according to the U.S. Census Bureau. While the Hispanic population is significant in Ventura County, only 4.62% of the entire population speaks limited English according to the same 2019 ACS. This suggests that while Spanish-language creative is important to include in our outreach, the majority of the Hispanic population can still be reached with English-language creative.

To reach the Hispanic community in Ventura County, Spanish-language elements including radio and digital ads were utilized in the spring 2023-24 campaign. With significant digital ad over-delivery, Spanish-language paid media delivered higher CTRs than English on both display and mobile ad messenger.

# BILLING AND CUSTOMER SERVICE






# CITIZEN'S ADVISORY COMMITTEE (CAC) MEETINGS

The CACs serve as a liaison between the community and the Ventura County Waterworks Districts (VCWWD) by providing input to Water and Sanitation Department staff and the Board of Supervisors.

There are four CACs representing each of our Waterworks Districts, these include our largest District No. 1 (Moorpark), followed by District No. 17 (Bell Canyon, District No. 19 (Somis) and finally, District No. 38 (Lake Sherwood).

We also continue to offer the ability to attend meetings virtually to increase community participation.

Spanish speaking staff are also available at all meetings to assist with translation, if needed.



# NEW RESIDENTIAL SOLID WASTE & RECYCLING AGREEMENTS

Starting January 1, 2024, new 10-year residential solid waste and recycling collection agreements with E.J. Harrison and Athens Services took effect in unincorporated Ventura County. Managed by the Integrated Waste Management Division (IWMD), these agreements offer reduced monthly rates and expanded services for all residents enrolled in collection services.

### **New Residential Services**

Increased bulky item pickups: single-family customers will have (3) bulky item collections, and multifamily complexes will have up to four (4) designated collection events per calendar year

Door-to-door Household Hazardous Waste Collection Program, up to (4) collections per calendar year per household

Free compost and mulch

Bimonthly outreach and education in English and Spanish

On-premises services free-of-charge for customers where all adult service recipients residing at the home have disabilities preventing them from the placement of their carts at the curb for collection Twelve annual Neighborhood Cleanup events offering free drop off trash, bulky items, yard waste e-waste collection and document shredding

Annual pre-pay discount and monthly discount for residents 62 years of age or older who are enrolled in the SoCal Edison or SoCal Gas CARE program

Annual rate increases capped at 4%

New collection containers in state-required colors black (trash), green (organics), and blue (recycling)

Free indoor kitchen food scrap pails and backyard compost bins

Among customers who responded to a Public Works survey in April 2024, 86% rated their overall satisfaction with residential trash and recycling services as 4 or higher on a scale of 1 to 5.
