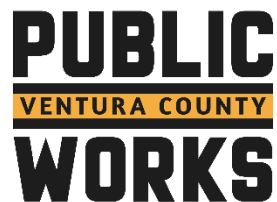

WILL SERVE LETTER INSTRUCTIONS

A Will Serve Letter is a letter from a Water Purveyor declaring that the purveyor's system will provide a water or sewer service to the proposed project identified in the letter. The process for receiving this letter is outlined in the checklist below. Please submit the project forms, included, via email to wsdevelop@venturacounty.gov or in person at the front office located at 6767 Spring Road, Moorpark CA 93021. CUSTOMER WILL SERVE LETTER PROCEDURE CHECKLIST		
1	Customer Information Form and Application for Service if applicable. <i>(Form is located within Information Packet on page 4)</i>	
2	Submit Planning Department approved drawings. <i>(Both electronic and hard copies are acceptable, non-planning approved acceptable for incorporated City of Moorpark)</i>	
3	Complete the appropriate Fixture Count Worksheet <i>(Form is located within Information Packet)</i>	
<i>The District will review information, determine the appropriate meter size for the project, sewer connection availability and provide the customer with a list of applicable fees.</i>		
4	If no changes are to be made to the existing services, customer will pay fees and receive a Will Serve Letter within four (4) business days of received payment.	
5	If changes are necessary but a construction permit is not required, the District will provide the customer with further information on what is needed.	
6	If one of the following scenarios apply, the customer will need to apply for a construction permit by completing the attached Construction Permit Checklist . • Upsize of water service line or existing sewer lateral • New water or sewer service connection • Relocation of an existing water or sewer connection

CONSTRUCCION PERMIT APPLICATION CHECKLIST		
A construction permit is required for the installation of a new service connection or the upsize of a service line. The following steps shall be completed prior to the issuance of permit.		
1	Submit Plan view drawings illustrating: • Water/Sewer main location and size • Water/Sewer service line size and connection from main to meter and/or sewer lateral and main connection • Water meter location and size <i>(if applicable)</i>	
2	Payment of all applicable fees.	
3	Submit Materials Submittals <i>(the District's Approved Materials List is available upon request)</i>	
4	Identification stakes or paint to mark the location of existing and new utility services.	
5	Verification of Contractor's Class A License Certification.	
6	Submit Certificate of Liability Insurance naming the District as additionally insured.	
7	Submit copies of Encroachment Permits (if applicable) • County • Caltrans • City • HOA	
8	Complete Application for Service Form Start or Stop Water Service - Ventura County Public Works Agency (vcpublicworks.org)	
9	Schedule a Pre-Construction meeting a minimum of five (5) working days prior to start of construction.
